## ARVON TOWNSHIP SCHOOL BOARD MINUTES MAY 19, 2020, 6:30 PM VIA ZOOM

The May 19, 2020 meeting was called to order by President Martin at 6:30 PM.

Members present were Martin, DeLine, Soli, Stiebe and Bollech. Staff, Johnson and Newland.

Agenda adopted with addition of Principal's Report by MMS Soli and DeLine.

Principal's Report: Johnson reviewed her report with the Board and among other items there will be no teacher evaluations conducted this year by direction from the State of Michigan. No School Improvement plan is required this year. We will be receiving Title I funds. Remote learning is going well with the final packet to be sent on May 26th. L'Anse school will be starting one week early with all other schools after Labor Day. Arvon's calendar will be available at our June meeting. The bullying policy was reviewed and on MMS Soli and DeLine was approved as written. On MMS DeLine and Soli, lunch prices to remain at \$1.15 for regular lunch, 40 cents for reduced lunch and 15 cents for milk. Board members reviewed changes made to the absence policy (student handbook) and were in agreement with the policy as written.

Finance Report: Newland reviewed the monthly statement and bills. Total liabilities and equity equals \$615,251.02. On MMS DeLine and Bollech to accept the monthly statement and pay the bills. All ayes by Martin, DeLine, Stiebe, Soli and Bollech. Nays none.

A. Chromebook update: Newland reported that 9 Chromebooks have been ordered. The school has received a total of \$2,205 from Certainteed. Through REAP and Title I funds additional Chromebooks will be ordered.
